## **TERMS AND CONDITIONS APPLICABLE TO ALL VISITORS TO NORMAN PARK ATHLETICS TRACK, PAVILION AND FACILITIES**

1. By visiting the grounds of the athletics track, pavilion and facilities at Norman Park (the “**Athletics Facilities**”), you agree to be subject to these terms and conditions, which may be amended by us from time to time by posting the amended version on our website at <https://nptm.co.uk/terms-conditions/>.

### **Visitor Admission and Conduct**

2. You agree, at all times while visiting the Athletics Facilities, to comply with these terms and conditions and with any directions given to you by us, our employees or authorised representatives.
3. You will only be admitted to and permitted to use the athletics track or field facilities upon the purchase of a session admission ticket or the presentation of a valid annual or six-month pass at the entrance to the Athletics Facilities, unless you are visiting (with our permission) as a guest athlete during a competitive event.
4. The purchase of a session admission ticket allows you access to and permits you to use the athletics track or field facilities only for the relevant session and on the date of purchase.
5. You must carry your session admission ticket or annual or six-month pass at all times when on site at the Athletics Facilities and you must show it on our reasonable request to do so.
6. You must comply at all times with the rules of ‘Track & Field Conduct on Training Sessions’, which are posted on the noticeboard at the entrance to the Athletics Facilities (and which may be amended from time to time).
7. We reserve the right in our sole discretion to refuse the admission of any person to the Athletics Facilities, to refuse permission to any person to use any part of the Athletics Facilities, or to eject any person from the Athletics Facilities, and our decision shall be final and binding. Without prejudice to the generality of the foregoing, we have the right to refuse admission or permission to, or eject from the Athletics Facilities, any person who is:
  - (1) under the influence of drugs or alcohol, and/or
  - (2) conducting themselves in an inappropriate manner, and/or
  - (3) inappropriately or inadequately attired.

8. We reserve the right to close the Athletics Facilities during ordinary opening hours and to require visitors to leave, if circumstances reasonably so require.
9. Smoking (including the use of e-cigarettes) and/or the use or consumption of drugs or alcohol at the Athletics Facilities is strictly prohibited.
10. Nuisance, offensive or abusive behaviour of any kind is prohibited, including any form of abusive, racist or sexist language and any type of anti-social conduct.
11. Animals, other than guide, hearing or assistance animals, will not be admitted to the Athletics Facilities.
12. Any person in possession of an item which is illegal or which is reasonably considered by us, our employees or authorised representatives to be dangerous, may be refused admission or ejected from the Athletics Facilities.
13. In relation to photography at the Athletics Facilities, you agree as follows.
  - (1) You agree not to bring any camera, video camera, sound recording equipment or other photographic equipment onto the Athletics Facilities for commercial purposes without first obtaining written permission from us.
  - (2) You agree not to photograph and/or record video footage of any other visitor to the Athletics Facilities without first obtaining their permission to do so.
  - (3) You agree that we, our employees or our authorised representatives may (on demand made on reasonable grounds) have access to any photographs or video footage that you have taken at the Athletics Facilities. You also agree to comply immediately with any request by us, our employees or authorised representatives that photographs or video footage be deleted if they are reasonably considered (by us, our employees or representatives) to be offensive to or to infringe the privacy or other rights of any visitor or of any of our employees or authorised representatives.
  - (4) Occasionally, we or other persons authorised by us carry out photography and/or video recording at the Athletics Facilities, which may capture images of visitors. By entering the Athletics Facilities, you agree that we or such other persons authorised by us may capture and use in perpetuity such images in promotional, advertising or publicity material in any format whatsoever, without granting you any right to payment. When filming takes place, we will display a sign giving notice thereof.

### **Liability**

14. You acknowledge and agree that you will be liable to us for any damage caused by you to the Athletics Facilities or to any of their fixtures, fittings or contents and/or for any injury caused by you to any of our employees or authorised representatives or to any other visitors during your visit.

15. Except in respect of any personal injury or death caused directly by our negligence, or any other liability that cannot (as a matter of law) be excluded or limited:
- (1) we exclude liability (whether in contract, tort, negligence, breach of statutory duty or otherwise) for any loss, damage, cost, expense, injury or death suffered by you or for any loss or damage to any item of property belonging to you, howsoever arising;
  - (2) any other liability that we have to you shall be limited to the price of your admission ticket or pass;
  - (3) under no circumstances will we be liable to you or to any third party for any wasted expense, loss of income or profit, or any indirect, consequential, financial or economic loss or damage, howsoever arising.

### **General**

16. These terms and conditions shall be governed by and construed in accordance with English law.
17. Any disputes arising under or in connection with these terms and conditions shall be subject to the exclusive jurisdiction of the courts of England and Wales.
